PERSONAL PROPERTY TAX PAYMENTS; PAYABLE TO TOWN OF OCONTO FALLS . ALL PERSONAL PROPERTY TAX BILLS ARE DUE IN FULL BY JANUARY 31, 2018. PAYMENTS MUST BE POSTMARKED BY JANUARY 31, 2018, AND MAILED TO : SUE KONITZER, 8542 CTY CC, OCONTO FALLS, WI. 54154.

TAX PAYMENTS MADE BY YOUR FINANCIAL INSTITUTION; IF YOUR CHECK IS MADE PAYABLE TO YOU AND THE TREASURER, YOU MUST SIGN THE BACK OR IT WILL BE RETURNED TO YOU FOR YOUR SIGNATURE.

TAX OVERPAYMENT REFUNDS; IF YOU ARE MAKING A 1ST INSTALLMENT PAYMENT AND YOUR CHECK IS FOR MORE THAN DUE THE OVERAGE WILL BE APPLIED TO THE 2ND INSTALLMENT DUE, IT WILL NOT BE REFUNDED. IF YOU ARE PAYING IN FULL AND YOUR CHECK IS FOR MORE THAN THE FULL AMOUNT YOU WILL BE ISSUED A REFUND CHECK AT THE NEXT TOWN MEETING, WHICH WILL THEN BE MAILED TO YOU WITH A RECEIPT.
