

HIGHWAY MAINTENANCE
AGREEMENT
CHESTNUT AVENUE

It is hereby agreed by the City of Oconto Falls and the Town of Oconto Falls that the maintenance of Chestnut Road from the South line of the Gas Company property to its intersection with Hwy 22 shall be shared as follows:

1. The Town will do all snow plowing;
2. The City will do any required patching of the pavement.

The term of this agreement will be one year commencing on January 1, 1978, but will be renewable automatically for further terms of one year each, unless one party notifies the other, in writing, of its intent not to renew the same prior to thirty days from the end of the term.

This agreement is executed in duplicate by the Mayor and Town Chairman of the respective parties.

TOWN LINE ROAD AGREEMENT

TOWN OF SPRUCE AND TOWN OF OCONTO FALLS

PORCUPINE LAKE ROAD: 1 mile starting where road makes east/west turn to Fireside Rd. Town of Spruce will blacktop, maintain the road (including major road repairs), plow snow and cut grass on both sides. Any major bridge repairs will be divided between the two towns.

ST. AUBINS ROAD: .3 miles - Town of Spruce will take care of blacktop and maintain road. Town of Oconto Falls will cut grass on both sides of road and plow snow.

VALLEY LINE ROAD: Town of Oconto Falls will black top, maintain, plow snow and cut grass on both sides of road west of Kulhanek Lane to Daly Creek Road. Town of Spruce will black top, maintain, plow snow and cut grass on both sides of road east of Kulhanek Lane to County B and dead end road (.23 mi.) east of County B.

Degantown to Cty C --- Holtz Rd. 2 miles

Morgan will plow the snow and cut the grass both sides of the road
Cutting brush or spraying do our own side
East 1 mile of Holtz Rd. , Morgan takes care of blacktopping and maintains the road
West 1 mile of Holtz Rd. , Oconto Falls takes care of blacktopping and maintains the road

Delzer Circle .25 miles

Oconto Falls takes care of the whole road for everything

Cty C to Golden Corners Rd.-- Konitzer Rd .3 mile

Morgan will plow snow
Morgan cuts grass on both sides
Cut brush or spray on your own side
Oconto Falls will blacktop and maintain the road

Golden Corners Rd. to Elm Lawn Rd. -- Konitzer Rd. .7 mile

Morgan will plow snow, cut grass, blacktop, and maintain the road
Cut brush and spray on your own side.

Elm Lawn Rd. to Maple Street 1 mile

Morgan will blacktop and maintain
Oconto Falls plows, cuts grass on both sides
Oconto Falls will put rumble strips on south end of Maple St.
Oconto Falls will pay insurance premium on guardrail -
Any future improvements to accommodate safety measures will be equally shared by both towns
Cut brush and spray on your own side

Maple to Ostrenga Lane 1 mile

Oconto Falls will plow snow, cut grass on both sides, blacktop and maintain road
Cut brush and spray on your own side

Valley Line Road – Highway 22**

Gillett will maintain Daly Creek Road from Valley Line to Sunny Slope (1 mile).

Gillett will cut grass on both sides from Valley Line to Sunny Slope, and spray and cut brush on their own side from Valley Line to Highway 22.

Oconto Falls will maintain from Sunny Slope (1 mile) and plow and cut grass on both sides.

Gillett will maintain .25 miles and Oconto Falls will continue to maintain .75 miles to Highway 22, and cut grass on both sides.

Oconto Falls will plow Dale's Lane and Gillett will cut grass on same lane.
