***Mail in Tax Payments are preferred***

***MAIL IN TAX PAYMENTS: You will not receive a receipt unless you send a self-addressed stamped envelope along with your payment, as noted each year on your tax statement.***

***REAL ESTATE 1<sup>st</sup> INSTALLMENT OR FULL PAYMENTS:***  
***Payable to: TOWN OF OCONTO FALLS, DUE by January 31, 2022. Payments must be postmarked by January 31, 2022 and mailed to Sue Konitzer, Treasurer, 8542 County Road CC, Oconto Falls, WI 54154. If you want your tax payment for your 2021 income taxes, payment must be postmarked by December 31, 2021.***

***REAL ESTATE 2<sup>nd</sup> INSTALLMENT PAYMENTS: Payable to: OCONTO COUNTY TREASURER. Payments must be postmarked by July 31, 2022, and mailed to Oconto County Treasurer, 301 Washington ST, Oconto, WI 54153***

***PERSONAL PROPERTY TAX PAYMENTS: Payable to the TOWN OF OCONTO FALLS. All Personal Property Tax Bills are due in full by January 31, 2022. Payments must be postmarked by January 31, 2022, and mailed to Sue Konitzer, Treasurer, 8542 County Road CC, Oconto Falls, WI 54154.***

***TAX PAYMENTS MADE BY YOUR FINANCIAL INSTITUTION: If your check is made payable to you and the Treasurer, YOU MUST SIGN the back or it will be returned to you for your signature.***

***TAX OVERPAYMENT REFUNDS: If you are making a 1<sup>st</sup> installment payment and your check is for more than due the overage will be applied to the 2<sup>nd</sup> installment due, it will NOT be refunded. If you are paying in full and your check is for more than the full amount you will be issued a refund check at the next Town Board Meeting, which will then be mailed to you with a receipt.***

***DOG OWNERS: License for all Dogs are due in January. Fees are as follows***

***Neutered Males \$3.00 Spayed Females \$3.00***

***Males \$8.00 Females \$8.00***

***Kennel Licenses are \$35.00 for up to 12 Dogs, each additional dog is an additional \$3.00 per Dog.***

***A current Rabies Certificate of Vaccination is REQUIRED to obtain a license.***

***If you have rental property, please advise your renters that they must license their dogs.***
