

Town of Oconto Falls Regular Board Meeting Minutes Monday April 10, 2023, 6 p.m. at the Town Hall

Motion to approve the agenda made by Kaczmarek, second by Peterson. Motion carried.

Motion to approve the minutes of the last meeting as published made by Kaczmarek, second by Peterson. Motion carried.

Rieth presented the treasurer's Report.

The motion to pay bills except for check 6200 to OCEDC was made by Kaczmarek, second by Peterson. Motion carried. We will do research on what our benefits are and present at May's meeting.

Adam Cole has requested a Conditional Use Permit to operate a business to repair, clean and modify guns at his residence by appointment only, no open shop. This request was approved by the Town Planning Commission and is on the agenda for county approval on April 25th. Motion to approve made by Peterson, second by Kaczmarek. Motion carried.

Residents on Coffee Lane have requested a slow no wake zone be enacted along the Oconto River in the Coffee Lane area. The completed application was presented to the Town Board to be approved and submitted to the County. The Town will purchase the buoys and get them installed upon approval by all parties. Town Ordinance #18 will be amended to include the additional area. Motion made by Peterson to approve the request, second by Kaczmarek. Motion carried.
