Town of Oconto Falls Regular Board Meeting Minutes Monday August 14, 2023, 6 p.m. at the Town Hall

- Chairman Alsteen called the meeting to order at 6pm. The Pledge of Allegiance was recited.
- Roll Call-Alsteen, Peterson, Kaczmarek, Rieth, Mogged present for the board. Robbi Hron, Tom Hron, Bob & Barb Wolf, Sharon & Wayne Wenzel, Rebecca & Paul Hinkhouse, Bob April, Roger Kane, Virgie Damp, Gail Schroeder, Keith Meyers present for the public.
- Motion to approve the agenda made by Kaczmarek, second by Peterson. Motion carried.
- Motion to approve the minutes of the last meeting as published made by Kaczmarek, second by Peterson. Motion carried.
- Rieth presented the treasurer's Report.
- The motion was made by Peterson, second by Kaczmarek to amend the budget to use \$16,500 of the ARPA dollars to purchase a road right-of-way mower to improve sight lines and the safety of our rural roads.
- The motion to pay bills was made by Kaczmarek, second by Peterson. Motion carried.
- There are no new developments on the Morgan/Oconto Falls Boundary Agreement.
- Bob Wolf recapped the initial Keller presentation held at the town hall on July 19. Keller will do a site and existing building study and present information concerning building new versus renovating. The study will be done for \$2500. They have asked for an additional \$1500 fee to have a structural engineer check the existing town hall foundation using a small back hoe. Kaczmarek made a motion to approve spending \$4000 for the study. Peterson second, motion carried. The money will be taken out of dollars already budgeted for town hall expenses and repairs.
- The crew is ready for Big Dumpster Day at the Town Hall 8-19-23. They will keep checking for town stickers.
- Public Comment Robbi Hron lives on the West end of Coffey Lane. He expressed concern about the slow no wake buoys recently installed near his home. He feels slowing down the water flow in the river channel in front of his home will increase the amount of sediment in the channel. In just a few years, the water depth has gone from 6' to 2'. He feels faster boat traffic will keep the channel open. After discussion it was decided the west buoy will be pulled and further study will be conducted for placement.

Roger Kane stated there are still no "No engine braking" signs on Hwy 22 near his home. Alsteen stated that is a state highway and the town and county can not place signs on it. Discussion was held on the amount of blacktop damage being created by the fiber installers.

Town Board Comment-Kaczmarek encouraged the public to look at the community Garden behind the ambulance garage. It is very impressive. Board members have heard good comments about our road crews. The September meeting date is changed to September 18.

Peterson made the motion to adjourn, second by Kaczmarek. Motion carried.
