

Town of Oconto Falls Regular Board Meeting Minutes Monday October 9, 2023, 6 p.m. at the Town Hall

Chairman Alsteen called meeting to order, followed by the Pledge of Allegiance.

Roll Call-Kaczmarek, Peterson, Rieth, Mogged, Alsteen present for the board. Robert Aprill, Wayne and Sharon Wenzel, Rebecca Hinkhouse, Bob & Barb Wolf present for the public.

Kaczmarek made the motion to approve the Agenda, Peterson second. Motion carried.

Kaczmarek made the motion to approve the minutes of the last meeting as published, Peterson second. Motion carried.

Rieth presented the Treasurer's Report

Kaczmarek made the motion to pay bills, Peterson second. Motion carried.

Alsteen met with the city about the fire and recycling center contracts in preparation for budget discussion. Kaczmarek will meet with the ambulance service concerning their contract. The recycling contract will stay the same, the fire and ambulance will have a 3% and 2% increase respectively.

The Morgan Town Board reached out again about the Morgan/Oconto Falls Boundary Road Agreement. They would like it reworked. The board will attempt to find a time to meet with them.

Bob Wolf presented plans and information Keller brought to us on October 5th. The plans were created from information Keller gathered in September. The intent was for the committee to point out necessary changes and make improvement suggestions to the plans. Keller will create new plans with projects broken into groups and present them with pricing on November 2nd at 1pm.

The date and time for the Public Budget Hearing, the Special Town Elector Meeting to set the Levy and the Special Town Board Meeting to adopt the 2023 Town of Oconto Falls budget, will be held consecutively the same night as the regular November board meeting on November 13 starting at 5:15pm.

There is another Big Dumpster Day on October 21th, 2023, 7am-4pm. Everything is ready.

There was no Public Comment.

Town Board Comment-Mogged-1. The legislature reworks absentee envelopes every 2 years. A very popular vendor made a mistake on the envelopes and will replace them at no cost. 2.The county Land office wants everyone to be aware of the importance of physical address signs which are available through the county. 3.There is a grant for an ADA compliant screen for our voting machine which will make the disabled voting process smoother. The state will pick up the cost except for \$50 plus shipping.

4. The Rusch property on Highland Drive has requested to be annexed to the city.

5. There will be action on the county board soon concerning library funding. The committee has narrowed the potential solutions to 2. The county clerk will have funding information at the next meeting in Oconto Falls on November 15.

Peterson made the motion to adjourn, Kaczmarek second. Motion carried.
