- Wednesday, January 24th, 3:00 pm to 6:00 pm

REAL ESTATE 1st INSTALLMENT OR FULL PAYMENTS:

- **Payable to: TOWN OF OCONTO FALLS**
- **DUE by January 31, 2024.**
- **Payments must be postmarked by January 31, 2024 and mailed to Sandy Rieth, Treasurer, PO Box 130, Oconto Falls, WI 54154.**
- **If you want your tax payment for your 2023 income taxes, payment must be postmarked by December 31, 2023.**

REAL ESTATE 2nd INSTALLMENT PAYMENTS:

- **Payable to: OCONTO COUNTY TREASURER**
- **Payments must be postmarked by July 31, 2024, and mailed to Oconto County Treasurer, 301 Washington ST, Oconto, WI 54153**

PERSONAL PROPERTY TAX PAYMENTS:

- **Payable to the TOWN OF OCONTO FALLS**
- **DUE IN FULL by January 31, 2024.**
- **Payments must be postmarked by January 31, 2024, and mailed to Sandy Rieth, Treasurer, PO Box 130, Oconto Falls, WI 54154.**

TAX PAYMENTS MADE BY YOUR FINANCIAL INSTITUTION:

- **If your check is made payable to you and the Treasurer, YOU MUST SIGN the back or it will be returned to you for your signature.**

TAX OVERPAYMENT REFUNDS:

- **If you are making a 1st installment payment and your check is for more than due, the overage will be applied to the 2nd installment - it will NOT be refunded.**
- **If you are paying in full and your check is \$10 or more over the full amount, you will be issued a refund check at the next Town Board Meeting, which will then be mailed to you with a receipt. If it is less than \$10, you must request to receive a refund check.**

IMPORTANT DOG LICENSE **INFORMATION**

DOG OWNERS: License for all Dogs are due in January. Fees are as follows:

- Neutered Males \$3.00
- Spayed Females \$3.00
- Males \$8.00
- Females \$8.00
- Kennel Licenses are \$35.00 for up to 12 Dogs.
Each additional dog is an additional \$3.00 per Dog.

A current Rabies Certificate of Vaccination is **REQUIRED** to obtain a license.

If you have rental property, please advise your renters that they must license their dogs.

Please send a self-addressed stamped envelope along with your payment. This will be used to send your receipt, dog tag, and rabies certificate.

Please follow the instructions below to access your tax bill on-line.

- **Access the Oconto County Website**
 - **www.co.oconto.wi.us**
- **Make sure that you are on the 'Home' page**
- **Scroll down the page and click on the 'Taxes & Maps' link**
- **Click on the 'Public GCS Tax Information' blue box**
- **You must accept the terms and conditions to continue**
- **Enter some description information**
- **Click the 'Search for Properties' dark blue box**
- **If multiple parcels are found – select a parcel**
- **Click on the 'Taxes' link**
- **Scroll down the page and click on the 'Print Tax Bill' dark blue box (may not be available when on a small screen, i.e., phone, etc.)**
