The motion to pay bills was made by Peterson, second by Kaczmarek. Motion carried.

- Busy Nook Road bids were opened for the western most portion of Busy Nook Rd, 7/10 of a mile. We received a road grant for \$20,912.20. Richlein Excavating, Crivitz, WI submitted a bid for \$108,317. Duame Sand & Gravel submitted a bid for \$115,532. Oconto County Highway Department submitted a bid for \$112,017.94. Kaczmarek made the motion to accept the Richlein Excavating bid for the LRIP Busy Nook Rd project for \$108,317. Peterson second, motion carried.
- Rieth was contacted by Willing Workers 4H about holding a rummage sale at the Town Hall sometime in June. Kaczmarek made a motion to allow them the use of the town hall at no cost. Peterson second, motion carried. There was a question from the public as to liability in case something happened. Mogged will check with our insurance as to coverage.
- Rieth was contacted by Willing Workers about them doing a Service Project at the Town Hall. Their intent is to paint and do some basic repairs to the outside of the building. Peterson made the motion to approve their service project. Kaczmarek second, motion carried.
- It is the year for the board to do the Paser regarding pavement ratings and road inspection dates must be set and noticed. June 23 and 24, from 3:30 to 5:30, were chosen. Kaczmarek made the motion to approve the dates, Peterson second, motion carried.
- May 31, 2025 is the date for our Electronics Recycling Event. Mogged will contact Sheriff Skarban about traffic flow questions.

Public Discussion-None

Town Board Discussion-Kaczmarek-OFAAS had their best year ever in 2024. They are in the process of updating all of their documents and bylaws. Alsteen-Oconto County's bid to pave the stretch of Busy Nook Rd we are doing this year was \$70,727.50. The road crew has been busy patching and doing sign work. The county painted over the graffiti on Busy Nook Rd. Per discussion at BOR, the Town revaluation will probably happen in 2027.
